CAREER PATHWAY TRAINING PROGRAMS (PATHWAY PROGRAMS) JVS'S CAREER PATHWAY TRAINING PROGRAMS PROVIDE EFFECTIVE SOLUTIONS TO THE BAY AREA INEQUALITY CRISIS BY CONNECTING LOW-INCOME JOB SEEKERS WITH THE SKILLS, WORK EXPERIENCE, AND CONNECTIONS NECESSARY TO SECURE CAREER PATH JOBS. THROUGH THIS APPROACH, JVS BRIDGES THE GAP BETWEEN EMPLOYER HIRING NEEDS AND JOB SEEKER SKILL NEEDS, RESULTING IN IMPROVED ECONOMIC MOBILITY AND A LARGER HIRING POOL OF HIGHLY QUALIFIED AND MOTIVATED EMPLOYEES FOR EMPLOYERS.
